LETTER OF REFERENCE

Backer OBR Sp z o.o., a member of international corporation **NIBE Industrier**, which is a group of companies located in Sweden, Norway, Finland, Denmark, Poland, Czech Republic, Italy, Spain, the Netherlands, Great Britain, China and Mexico, all united under a shared vision: to create world-class solutions in sustainable energy, would like to inform that our company contracted with **Eurostar** from Stargard Szczeciński management as an Contract Engineer a construction of expansion of the processing factory of heating elements in Pyrzyce.

Under the contract, which was implemented in the period from 06.2011 to 03.2014 **Eurostar** managed Project as an Contract Engineer. The scope of responsibilities was among others coordination and supervision of:

- design works with obtaining the required permits
- extension of the construction – filing and coiling technological platform in hall for production
- construction of extension of existing factory, consisting of: new production plant, high storage warehouse, canteen, workshop and other connected building of area exceeding 5.000m² and cubature 38.500m³
- products distribution system by dock houses and outdoor ramps
- internal electrical, mechanical, sanitary and dust filters installation
- all needed supporting infrastructure, which included execution of:
 - water supply and sewage pipelines, with an underground rainwater retention system
 - pre-insulated district heating pipelines with a new boiler which is under the supervision of the Technical Inspectorate
 - fire hydrant water tank which is a heat accumulator, in order to recover in the future energy from technological processes
 - electrical cable lines with a new transformer station
 - parking for cars
 - roads and yards
 - interior design of the entrance to the main office building
 - area development with a small architecture and paved roads and yards at area exceeding 8.830m²
 - modernization works on existing processing factory including: implementation of a new canteen, workshop and quality control office and premises.

Besides that Eurostar organized and proceeded three tender procedures successfully completed with choosing Contractors and contract signing.

The value of works exceeded amount of: **16.000.000,00 PLN** with VAT tax.
